



## CARBON CONSULTANCY COSTS

### Woodnet Indicative Costs for Carbon Services

These are minimum fees based on receiving full and clear information and additional work over and above usual processing times may be charged.

Initial carbon profile	\$50.00
Open an NZEUR account.	\$500.00
<b>Pre-1990 (FAP)</b>	
<p><i>If allocation area = 30 hectares or less:</i> Complete a standard pre-1990 forest allocation application including:</p> <ol style="list-style-type: none"> <li>1. Confirming applicant eligibility.</li> <li>2. Mapping and shape file creation.</li> <li>3. Determining claim amount.</li> </ol>	\$1,500.00
<p><i>If allocation area = over 30 hectares:</i> An additional \$10 per hectare will be charged for the approved allocation area over and above 30 ha.</p>	\$10 p/ha above 30 ha
Apply for excluded transfer to enable credit claim lift from 39 to 60 units per hectare.	\$300.00
Apply for exemption from the deforestation obligations of the ETS for pre-1990 forests landowners.	\$1,000.00
<b>Post-1989 (ETSA)</b>	
Complete a post 1989 forest ETS application. ( <i>If area = 30 hectares or less</i> )	<p>\$1,000.00 if information provided cleanly <b>plus</b> \$488.89 MAF fee (required in advance) <b>plus</b> \$300.00 if there is a forestry right</p>

Post-1989 (ETSA) cont.	
<i>If approved area = over 30 hectares:</i> An additional \$10 per hectare will be charged for the approved area over and above 30 ha.	\$10 p/ha above 30 ha
Add CAA to existing participant	POA <u>plus</u> \$88.89 MAF fee (required in advance)
Completing emissions return (required annually) including holding backup records.	\$220.00 (for up to 5 CAA) <u>or</u> \$250.00 (for up to 10 CAA) <u>includes</u> \$88.89 (MAF fee) <u>plus</u> \$5.00 (per CAA over and above 10 CAA's)

Carbon Credit Sales	
Brokerage on carbon credit sales.	1% + GST <u>OR</u> \$250 + GST (whichever is the greater)
